

Bring teen Mental Health First Aid to NJ

Submission Instructions

The application will open on July 26, 2021, 9:00 a.m. ET. Applications must be submitted online.

Completed applications must be submitted online by August 20, 2021, 11:59 p.m. ET.

Please be sure to complete each of the following application components before submitting your application:

Note: Only applications that are complete and submitted will be reviewed.

This application should take approximately 20 minutes to complete. It should be completed by an employee familiar with your school or organization's workforce training and general mental health support. The application does not have to be completed in one sitting; your responses can be saved as needed.

Because of the large volume of applications we expect, preference will be given to schools and organizations that can meet the criteria of implementing tMHFA with fidelity, can follow all required safety protocols, and who are looking to implement a mental health or social-emotional learning program for students, along with schools and organizations serving communities in higher-need areas.

Overview

The National Council for Mental Wellbeing invites you to apply for a new learning opportunity for schools and youth-serving organizations across New Jersey. This is a two-year initiative that will run through September 2023. The 50 selected sites will be asked to commit to Year 1 of the project through the 2021-2021 school year. After Year 1, sites will be given the opportunity to apply to join a smaller cohort of 25 sites for Year 2.

About teen Mental Health First Aid: tMHFA is an evidence-based training program for teens in grades 10-12, or ages 15-18, that teaches teens how to identify, understand and respond to signs and symptoms of mental health and substance use challenges among friends and peers. Learn more about tMHFA.



Eligibility Requirements:

- Must be a school or youth-serving organization in New Jersey.
- Must be able to implement tMHFA for teens in grades 10-12, or ages 15-18. At this time, grade 9 and post-secondary students are not permitted to participate.
- Must be able to meet the criteria of implementing tMHFA with fidelity:
 - o If teaching at a school, the course should be taught to an entire grade level of students (not individual classes) in the school. If teaching at a youth-serving organization or program, the course should be taught to an entire group of students at the youth-serving organization or program.
 - o Schools and organizations should seek to have approximately 10% of staff at the site trained in Mental Health First Aid (MHFA) for Adults Assisting Youth (YMHFA). This training gives adults who work with youth the skills they need to reach out and provide initial support to children and adolescents (ages 6-18) who may be developing a mental health or substance use challenge and help connect them to the appropriate care. The National Council will assist in meeting this goal by providing training for up to 20 adults per school or organization.
 - o The school or organization offering the training must have a safety protocol in place to ensure student safety, including how to respond to a teen who's in distress and indicates a need for follow-up.
 - o The course should be taught in classes of approximately five to 30 teens on nonconsecutive days. The program should not be taught in large, assembly-style sessions.
- Participation in a virtual, professional learning community for the certified tMHFA Instructors and their implementing teams. This opportunity will provide Instructors and their teams with a space for peer-to-peer support. It will also support them in creating safe and supportive learning environments by exploring content such as trauma-informed classroom strategies, culturally responsive teaching and best practices for affirming the identities of diverse adolescents. The learning community will run from October 2021–June 2022.
- Commitment by your school or organization's leadership and any other key stakeholders to implement this training and for participation in the virtual, professional learning collaborative.
